1. The minutes of the March 11, 1999 CMMCP Commissioner's minutes were unanimously approved.

Field crews have begun larviciding, and have reported drier than usual conditions, but larvae are present whenever areas are wet.

6. New Business: The Superintendent informed the Commission that the Town of Ayer has voiced concerns regarding pesticide usage in town. Ken attended a Selectmen's meeting on April 5, and will send more information for them to look over. One final selectmen's meeting will be held on

The Town of Chelmsford is scheduled to do its aerial larvicide sometime the week of April 16-23. Project personnel will be on hand to assist.

The Superintendent reported that the Project will conduct field trials of a new adulticide, Aqua-Reslin®, the week of June 28. Consultants from Clarke Mosquito Control Products will be on hand to offer assistance and technical support. It's the intention of the Project to give a presentation of the results at the next NMCA Annual Meeting to be held in Plymouth, MA.
