1. The minutes of the preceding meeting of March 13, 1990 were received and unanimously approved.

2. The following payrolls were unanimously approved:

3. Invoices amounting to \$1,399.21 were approved unanimously.
4. Water Management with one machine working; several water management jobs completed; started larviciding with BTI granules and will switch to Witco oil when pupae appear. Warm weather and constant refilling of wetlands will cause bumper crops of mosquitoes in 1990. Will start on adulticiding as soon as weather dictates. Will plan on working nights Monday through Thursday. Social activities in the towns will restrict operations for Friday, Saturday and Sunday.
5. Commissioners unanimously approved David Scott's expenses of \$111.80 to go to the New Jersey Mosquito Control Association meeting.
6. The Commissioners unanimously approved the expenses for David and Ken to go to the American Mosquito Control meeting of \$1020.50 each and \$495.50 for Curt.
7. Budget 2nd Spending Plan: Due to the uncertainty of 13 Accounts a late filing was accomplished; however, David was able to collectively transfer accounts to compensate for the 13 Account.
8. Reclamation Board costs to be apportioned to towns and given to them as an additional item. We need more information from the Reclamation Board in order to understand and justify this expense to our towns. Malcolm Henry will write a letter to Charlie Costa.
9. Town Meetings:  
Natick voted to join our project (\$29,000.00)  
Sherborn voted to stay in our project.  
Town meetings coming up which have articles to vote out;  
voting out is due to the way the State handled the budget.
