C. The active Mosquito Control Projects through a united front of the Superintendents and their Commissioners will begin work on new legislation.

8. EEE virus reports for last week were negative. Reports will be coming in weekly.

9. Pesticide sub-committee meeting was petitioned by Mass. Audubon to ban resmethrin or have the registration rescinded. It did not happen. Another motion was made and passed to review registration of all products used to control mosquitoes.


