1. The minutes of the February 11, 1992 Commissioners Meeting were unanimously approved.

2. The following payrolls were unanimously approved:

- 3. Invoices totalling \$2115.79 were unanimously approved.
- 4. Water Management jobs completed in Westborough and Natick. Started job in Boxborough but found too much ice. Moved to Hudson. Have a project in Shirley which is presently being held up due to transfer of ownership which necessitates getting permission from new owners.

Littleton job coming up. Fitchburg job was done on Electric Avenue. Inside work progressing whenever inclement weather puts a stop to outside jobs.

Plan on larviciding first week of April; weather permitting.

- 5. News releases were sent out to all our towns on 2/10/93. These hit the papers and they notify people who are No Sprays to notify their city or town clerk prior to March 1st. We will pick up the "No Spray" and abide by them.
- 6. Annual Report was given to each Commissioner at this meeting. Individual Town Reports were distributed to each town along with appropriate videos. There have been 180 videos disbursed in our area, including several copies to cable TV stations.
- 7. A copy of Legislature up-date of 252 was presented to each Commissioner. Hopefully it will get a House Reference Number. Upon receiving this reference number, we then can start the promotion of it.
- 8. The Town of Acton wishes to rejoin our project. All necessary correspondence pertaining to it was included in each Commissioner's packet. Certainly David's answer dated 3/10/93 is a most comprehensive outline of our project's operation and he should be complemented for such a masterpiece.

9. Town of Westford correspondence is rather self explanatory but very interesting. First, CMMCP is not a standby emergency mosquito control project; it is a 365 days a year operation with proper professional knowledge and modern equipment to set in motion a continued source reduction program and to effectively administer such a program.

David's letter of 3/12/93 (tomorrow) is right on track - it's beautiful.
