4. Work Schedule: Finished most of the adulticiding by the end of September. Did a couple of special event sprayings. Water management work entailed cleaning culverts and brush cutting. Finished up a large water management project in Blackstone and Project personnel are in the process of moving the equipment to Hudson.

The new big truck was delivered today. Project personnel will spend some time making it field ready. Bids for the new heavy equipment trailer were recently opened and the trailer should be delivered in a few weeks

5. EE Report: No EE virus was detected this year by the State virus lab.

An 8-month old Springfield child has contracted EE. The child in is a coma and not doing well. In trying to determine where the child may have come in contact with the virus it was noted that the family vacationed in Sturbridge, MA. This was the only traveling the family did this year.

- 6. 1995 Season Report: Because of the very dry summer season pesticide usage was less this year than last. Despite the fact that Project personnel had to cover more area in 1995 (because of additional towns being added to the project) the number of calls was reduced because of the drought. The number of calls for adulticiding in 1994 was 2,724 as compared to 1,652 calls in 1995. Requests for larvaciding was also reduced from 461 in 1994 to 260 in 1995.
- 7. Lease Update: DCPO has still not executed a lease contract for the CMMCP Headquarters. No news as to where it stands.
- 8. NMCA Meeting: The NMCA meeting will be held November 13-15, 1995 at the Cape Codder Hotel in Hyannis. Most Project personnel will attend. The CMMCP Commissioners will hold their next meeting at the conference on 11/14/95 at a noon luncheon.
- 9. Old Business: No old business.
- 10. New Business: No new business.
