- 1. The minutes of the December 21, 1995 Commissioners meeting were unanimously approved.

- 5. Legislative Update: Both the Superintendent's and Audubon's legislation are still in the works in Boston. If no action takes place by the end of this legislative season, these bills will die. They will have to be refiled if they are to become active proposals again.
- 6. Report on State Reclamation & Mosquito Control Board Meeting: The Board met on January 10, 1996. Topics of discussion included appointments of new commissioners, and rewriting of the GEIR. The draft GEIR was not approved by MEPA and MEPA is requesting that this document be redrafted. The Board is discussing how to go about preparing this document for MEPA review.

- 1995 Annual Report: The Annual Report should be ready by the end of January. A
 couple of sections need to be written and then it will be collated and ready for
 distribution.
- 8. Lease Update: Will wonders never cease, the lease has been executed. The CMMCP headquarters has a five year lease becoming effective February 1, 1996. The lease rate for the next two years is set at \$55,714.50 per year and the last three years it is set at \$61,079.60 per year.
- 9. Old Business: None.
- 10. New Business: Bob Armstrong of the East Middlesex Project recently passed away.

The staff is updating the Project's brochure and handouts.

Norfolk County Project has a position opening for Assistant superintendent. Tim Dechamps has applied.
