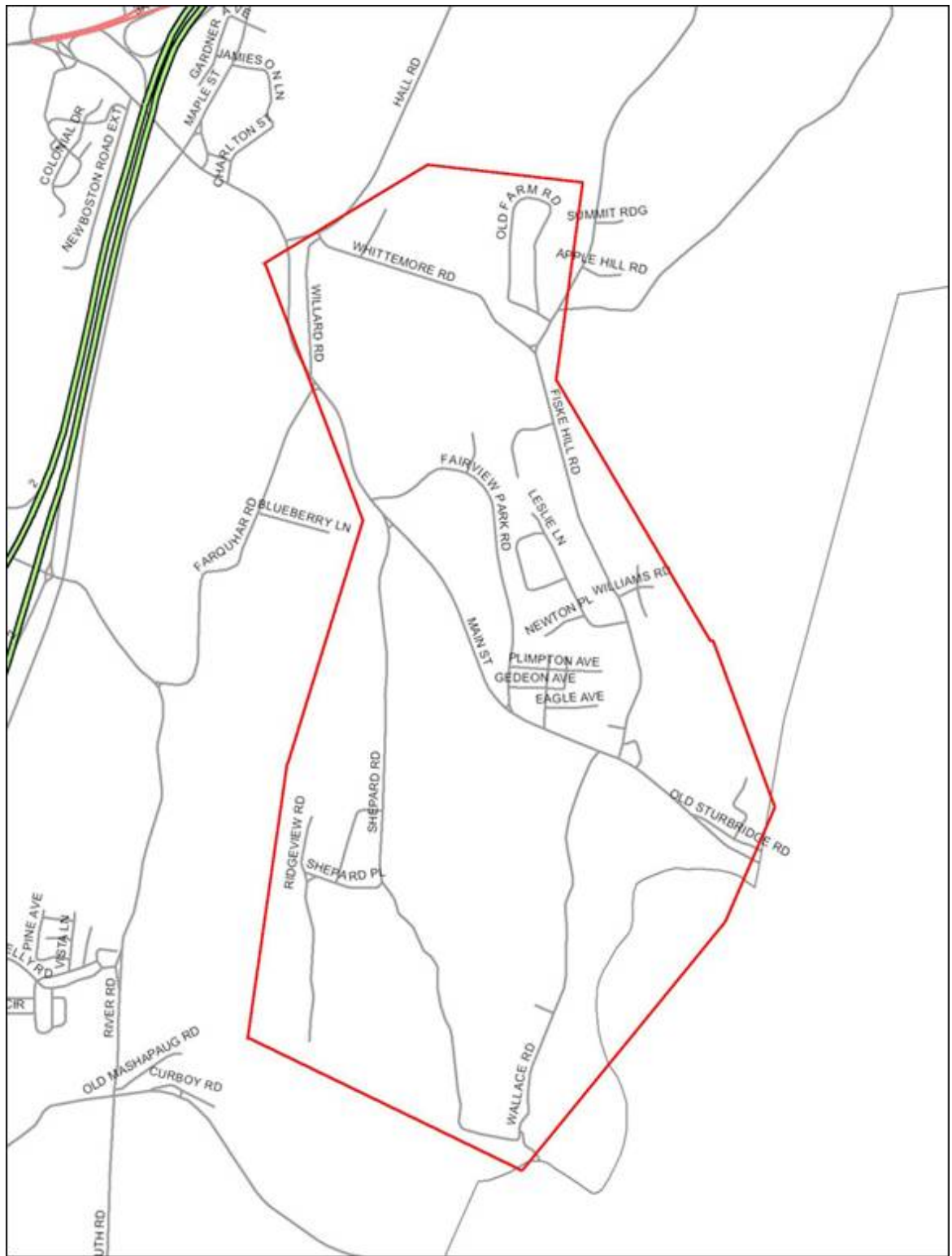
THE APPLICATION FOR THE EVENING OF AUGUST 30 IS COMPLETE: ALL AREAS OUTLINED BELOW WERE SPRAYED

Mosquitoes with West Nile Virus were confirmed August 24 in a surveillance trap set by CMMCP in the southeast corner of town from August 19.

CMMCP catch basin maps were checked and basins have been treated in the area. A spray area has been designated for the evening of August 30; see map and street listing below. **Please note: additional areas may be done in town by citizen's request.**

Additional surveillance traps have been set in the area to gauge population densities and for additional virus testing if necessary.

THIS IN RESPONSE TO SURVEILLANCE DATA COLLECTED THAT SHOWS A MODERATE POPULATION OF MOSQUITOES, NOT BECAUSE ADDITIONAL VIRUS HAS BEEN DETECTED.

Mosquitoes with West Nile Virus were confirmed July 27 in a surveillance trap set by CMMCP in the southeast corner of town from July 22.

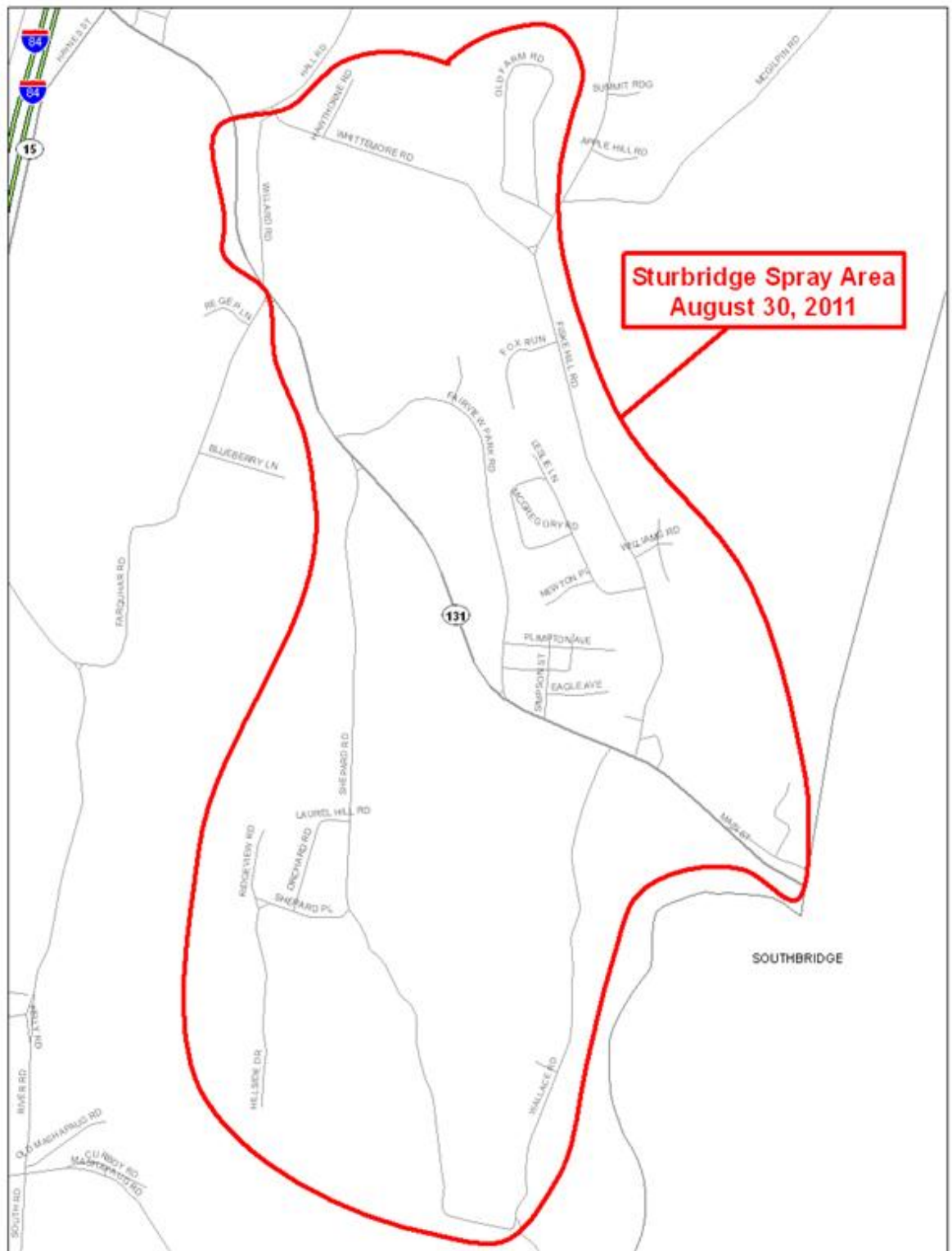
